 - announced new incentive for **SENATORS**: will be rewarding members who successfully refer a new student to applying to the GA with a food gift card
 - gave a reminder to respect the time of the GA, one's committees, and one's leadership teams in EC by staying focused during the meeting (no texting, inappropriate use of technology i.e. working on schoolwork during mtg, etc.)
- **Campus Committee Reports**
 - Academic Affairs Committee | Senator Kate Yocom
 - new academic catalog changes being made, will meet next on Monday, November 8th
- **Old Business**
 - none
- **New Business**
 - VP Little moved to allocate \$5,000.00 to lay down concrete sidewalk between Breech Hall and Springfield Hall, seconded.
 - Sen Armour inquired as to when construction for this would be able to start/the expected timeline for completion, VP Vonder Haar will meet w/ Brandon Gammill tomorrow and report back next week

- Pres. Hall called for a vote to allocate \$5,000.00 to lay down concrete sidewalk between Breech Hall and Springfield Hall, passed 13/0/0.
- Sen. Armour and Sen. Yocom moved to allocate \$15,000 to purchase new recreation equipment for the freshman dorm halls and the FSC Downunder student lounge, seconded.
 - discussion was held around the need for this as far as the age of existing recreation tables and the ability of them to be refurbished/fixed instead
 - the importance of determining the life expectancy of the new tables was expressed, Sen. Weldon clarified that 25 years was average
 - Sen. Russell expressed storage concerns for the increased equipment in the dorm halls
 - Sen. Clouse suggested looking into soundproofing for the walls in the dorms and FSC Down Under, in anticipation of increased activity post the purchase of new equipment
 - Sen. Jones inquired if we would take credit for the project, Sen. Armour clarified that the most we might do is post about it on social media, but not necessarily add any signage
 - VP Little inquired if we could see how the Campus Improvements budget would be affected (if project could be broken down into Phases and thus multiple NBPs)
- VP Vonder Haar proposed a friendly to increase the allocation to \$15,500, seconded.
 - Advisor Hinkle reminded the GA that SGA has almost completed the financial year, so this is money that we have budgeted for
- Sen Armour motioned to table this until next week, seconded, passed by unanimous consent.
- **Open Discussion**
 - Advisor Hinkle reminded the GA there are signed JAX concert posters in the SGA office and encouraged **SENATORS** to swing by and pick one up

- Sen. Jones informed the floor that the construction for the New Enterprise Center has destroyed a milkweed butterfly patch, seeking to work with people to let them know and work to rebuild and expand this patch
