 - Mtg was called to order @ 4:30pm by Pres. Rauscher. Roll was taken.
- **Approving the Minutes**
 - Motioned & seconded to approve last mtg's (Thurs, 25 March 2021) minutes at 4:35pm, passed 16/0/0.
- **Executive Council Reports**
 - **VP of Student Life**.....Ms. Haley Mueller
 - Sen Harless (for the Student Life committee)—
 - wtg on W-9 Form form back for mural commission, ad hoc committee to form to approve artist's designs
 - **VP of Institutional Affairs**.....Ms. Kate Hall
 - Friday of No Impact Week = Arbor Day Celebration, will collab w/ Facilities for equipment
 - VP Hall opened discussion to the floor about the time of the event (suggested 1-3pm), overall consensus was that 1pm will be prime for engagement
 - Sen Rispoli (for the Institutional Affairs committee)—
 - looking to promote DCycle with fliers (prior to event on Mon, April 19th)
 - Campus Readership Update - presentations to FUSE classes with the stress cubes coming up; cubes have QR codes to the link to the Campus Readership page on SGA's website

- **VP of Finance**.....Ms. Emily Little
 - Wrapping up meetings w organizations about their allocation requests
 - allocations will be presented to vote on next week in GA mtg, Advisor Hinkle suggested that **SENATORS** take the opportunity to look over allocations prior to mtg
- **VP of Communication & Public Relations**.....Ms. Alathia Keith
 - **REMINDER** follow our social medias and please reshare our posts; Pres Rauscher also implored the General Assembly to do this
 - an advertisement about applications being now open was sent in to *The Mirror*
 - in energy of DruryVotes, promoted local election this past Tues, April 6th
 - posted 'About SGA' info on our instagram in energy of educating constituency in order to encourage people to want to apply
 - **SENATORS** please send Comm Committee pictures from 1-on-1's w/ EC members
 - will be collabing with registrar's office to post info about BIPOC culture & history classes offered this coming fall semester
 - Comm Committee has been handed the SGA website credentials from Pres Rauscher
 - changing the way we do minutes - please review them each week
- **President**.....Mr. Nick Rauscher
 - he will be featuring in a university marketing video to talk about what SGA has done for the university
 - Faculty & Staff Townhall Update - Sen Armour
 - updates on COVID-19 protocols by the university & the university's use of government-distributed pandemic relief money were discussed

- Executive Vice President Chief of Staff Chief Operating Officer Chief Information Officer David Hinson reported new club sports (non-NCAA) will be offered in the future
 - Executive Vice President / University Relations General Counsel Aaron Jones reported a new program, “Badge to Bachelors”, is being implemented
- **Campus Advisor Report**.....Mr. Paul Hinkle
 - Drury = 1 of 2 schools in the ENTIRE USA to stay open the whole school year during COVID, Pres Cloyd acknowledged that SGA played a part
 - CDC reduced cleaning protocols as of 4:43pm TODAY
 - SGA superlatives/internal awards coming up, opened discussion on titles of awards
 - Drury Awards is coming up - Weds, April 28th
- **Standing Committee Reports** (excluding Food Committee & Senior Committee Reports, included already in VP Mueller’s EC Report)
 - **Elections Committee | Sen Greer**
 - REMINDER registration ends Mon, April 16th / campaigning opens Mon, April 12th
- **Campus Committee Reports** (excluding Student Health & Public Safety Report, included already in Pres Rauscher’s EC Report)
 - **Student Affairs Committee | Sen Schupbach**
 - New Enterprise Center, what sustainability practices are happening during and post construction (materials etc)
 - student housing was discussed, looking for ways to save energy with better infrastructure
 - Long Term goal for campus: carbon neutrality, paper-less
 - Sen Greer made sure to mention how the Enterprise Center won’t pull money from campus for maintenance & upkeep, has an endowment fund for that
- **Old Business**

- **New Business**

- Sen Greer moved to allocate \$1500 to fund the senior banquet, seconded.
 - expecting attendance of 120 ppl, existing resources = \$1800, \$1500 allocation would build on to \$1800
 - working w/ Career Planning & Development
- It was moved to a vote to allocate \$1500 to the Senior Committee, passed 16/0/0.
- Sen Clouse moved to allocate \$170 to the Pearsons Hall Artwork Installation Project, seconded.
 - got approval from Dean of the School of Humanities and Social Sciences Jennifer Brown & Director of Honors Program Rich Schur to put things on the walls in their building, Pearsons; solidified hanging mechanisms - railing system to hang the artwork
 - collabing w/ Rebecca Miller to get student artwork submissions
 - Advisor Hinkle asked for clarification on length of rails
- Sen Clouse moved to amend the motion on the floor to increase the length of the railing system to 12', thus increasing the allocation amount to \$250, seconded.
- It was moved to a vote to allocate \$250 to the Pearsons Hall Artwork Installation Project, passed 16/0/0.
- Advisor Hinkle applauded Sen Clouse on the completion of his \$1000 Project that began in the fall semester.
- Sen Rispoli moved to allocate \$1200 for the purchase of water bottle holders and a pressure washer for DCycle, seconded.
 - 39 bikes, looking to fund water bottle holders to mount on each bike
 - part of COVID cleaning procedures included the use of very abrasive chemicals on the paint and metal of the bikes, SGA suggested power washer instead - discussed funding one for DCycle because complications lending one from Facilities every time its needed

- at the DCycle event during No Impact Week, will be handing out water bottles
 - Point of Information, to rent a bike from DCycle, students must sign two waivers (liability release and emergency contact info)
 - mtg w/ Representative of DCycle Peter Monroe this coming week to discuss need for/benefits of power washer
 - discussion was had between members of the GA about the sustainability of a power washer, considering this is occurring during No Impact Week, and the impact of power washing on the paint on the bikes
- Sen Ohlson moved to remand the discussion around the purchase of a power washer for DCycle to the Institutional Affairs committee, with the intention the motion to allocate will be brought back to the General Assembly after more details are had and solidified, seconded.
 - Sen Schupbach called to question the benefit of splitting the motion into two allocations, one for water bottles and one for a power washer
- Moved to a vote to remand the discussion to the Institutional Affairs committee, division; vote by hands, motion failed.
 - Motion on the floor = to allocate \$1200 for the purchase of water bottle holders and a pressure washer for DCycle.
- Sen Schupbach moved to amend the motion on the floor to decrease the funding of the allocation to \$350 to be used for the purchase of the water bottle holders, with the intention that the power washer be brought back to the floor after more details are had.
 - discussion was held around the requirement of providing more details prior to a vote by the GA, Advisor Hinkle reminded the GA that it is not necessary for proposals under the amount of \$2000
 - discussion was had around the budget SGA has already allocated to DCycle
- Moved to a vote to amend the motion to decrease the funding, failed.

- Moved to a vote to allocate \$1200 for the purchase of water bottle holders and a pressure washer for DCycle, passed 16/0/0.
- **Open Discussion**
 - VP Mueller's Student Life committee has put together more mask making kits to hand out in the coming weeks
 - Sen Clouse called for a show of hand to gauge interest in SGA members attending ISA's International Food Festival this weekend
 - Sen Armor clarified that individuals attending the Panhellenic & Fraternal DU Olympics will be eating at the Festival
- **Call to Adjourn**
 - Motioned by VP Keith and seconded by Sen O'Brien at 6:00pm, passed 16/0/0.
